Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's raised 9ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures, 2.06mm width (at base) x 1.12mm depth, with cut-out underrail, open back settings, underneath.

Feature, "illusion solitaire style" design, with shoulder tones. Comprising, a raised four claw illusion setting to top. The extended shoulders, of the band tapers up, each having a channel set row, both sides.

Polished finish, stamped "375" GM16" - acid tested as 9 carat gold. Finger size R.

The ring contains;

Four illusion claw set Princess cut diamonds, clarity is "Si", colour is "I to J"(mixed), medium cut quality.
Average dimensions = 2.20mm (L) x 2.20mm (W) x 1.56mm (D-estimated)
Total Weight = 0.24ct (estimated - see NOTE below).

Eight channel set Princess cut diamonds, clarity is "Si", colour is "I to J"(mixed), medium cut quality.
Dimensions = 1.50mm (L) x 1.50mm (W) x 1.06mm (D-estimated)
Total Weight = 0.16ct (estimated - see NOTE below).

Total Item Weight = 2.83 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 2.75 grams, (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
