Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled, 22ct yellow gold & gemstone set, drop style pendant.

Feature; "drop style" pendant. Comprising, a six claw setting, open to back, houses one ovalshaped, faceted natural sapphire, claw set. To top, a trio claw setting contains three cubic zirconia. Above suspended from an articulated v-shaped bail.

Polished finish, unstamped - acid tested as & x-rayed approximately 22 carat gold.

Pendant dimensions = 21.50mm (total length inclusive) x 7.29mm (width) x 3.58mm (depth).

The pendant contains:

One claw set oval-shaped, faceted, natural sapphire, colour is "light - blue".

Dimensions = 10.43mm (L) x 6.89mm (W) x 2.62mm (D-estimated)

Total Weight = 1.58ct (estimated - see NOTE below).

Three claw set round cubic zirconia, colour is "colourless".

Dimensions = 2.01mm (average diameter) x 1.23mm (D-estimated)

Total Weight = 0.15ct (estimated - see NOTE below).

Total Item Weight = 1.59 grams, Total Gemstone Weight = 1.73ct, Total Metal Weight = 1.24 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
