Valuation for Traditional Retail Insurance Replacement

Item 1

One pair, of lady's hand-assembled raised, 9ct yellow gold & 14ct yellow gold, gemstone set, hoop earrings.

Feature, "hoop style earrings". Comprising, a channel setting, to front, alternating, synthetic emerald & diamond, channel set. Both with hinged clip & post fitted & attached.

Polished finish, stamped "9ct,14ct, 25" - acid tested as 9ct earrings, 14ct post's.

Earring dimensions = 14.28mm (L) x 10.64mm (W) x 5.14mm (D).

The earrings contains:

Four channel set round brilliant cut diamonds, clarity is "Si", colour is "J to K"(mixed), medium cut quality.

Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated) (smallest)

Dimensions = 1.98mm (average diameter) x 1.21mm (D-estimated) (largest)

Total Weight = 0.12ct (estimated - see NOTE below).

Six channel set round synthetic emeralds, colour is "medium dark - green".

Dimensions = 1.60mm (average diameter) x 0.98mm (D-estimated) (smallest)

Dimensions = 2.10mm (average diameter) x 1.28mm (D-estimated) (largest)

Total Weight = 0.12ct (estimated - see NOTE below).

Total Item Weight = 2.90 grams, Total Gemstone Weight = 0.24ct, Total Metal Weight = 2.85 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertain. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstone require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
