Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 1.70mm in width (at base) x 0.70mm depth, with hollow top and shoulders, and open back settings.

Feature multi-claw railed setting, housing seven marquise cut diamonds, tapering in size, claw set. Secured between the split shoulders of the plain and polished band.

Polished finish - stamped '14K ASB PJI with copyright symbol' - acid tested as 14 carat gold. Finger size is N.

The ring contains:

Seven claw set marquise cut diamonds, clarity 'Si', colour 'H'.

Dimensions = 4.07mm(L) x 2.51mm(W) x 1.75mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 4.82mm(L) x 2.77mm(W) x 1.92mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.85ct (estimated - see NOTE below)

Total Item Weight = 2.34 grams - Total Gemstone Weight = 0.85ct - Total Metal Weight = 2.17 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
