Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, diamond set, 'three stone' style ring, of cast construction.

Plain, narrow, low half round double band of 3.07mm width (at base) x 1.52mm depth, with open back settings.

Feature three bezel settings, spanning across the top of the band, each housing one round brilliant cut diamond, bezel set. The largest of the diamonds is to the centre. The settings are secured between the 'cross over' style shoulders of the plain and polished double band.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: P 1/2.

The ring contains:

One bezel set round brilliant cut diamond, clarity is "Vs", colour is "I to J" (mixed).

Dimensions = 3.83mm(Dia) x 2.38mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.21ct (estimated - see NOTE below)

Two bezel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "I to J" (mixed).

Dimensions (average) = 3.32mm(Dia) x 2.03mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.29ct (estimated - see NOTE below)

Total Item Weight = 4.31 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 4.21 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
