## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 9ct white gold and 9ct white gold, diamond set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 3.10mm width (at base) x 0.97mm depth, with a hollow top and shoulders, and open back settings.

Feature 'cross over' style ring. The two 'split' style shoulders, one of which, is yellow gold, and the other is white gold, have terminations that cross over in the centre of the band. Each of the shoulders is set with twenty round brilliant cut diamonds, bead set.

Polished finish.

Stamped '375' - acid tested as 9 carat gold.

Ring size: P.

The ring contains:

Forty bead set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.36ct (estimated - see NOTE below)

Total Item Weight = 4.13 grams

Total Gemstone Weight = 0.36ct

Total Metal Weight = 4.06 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
