Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct rose gold, gem set, flexible link necklet, of hand-assembled construction.

Feature 'trace' style link chain, with five oval synthetic sapphires, five oval fracture filled natural rubies, and five oval natural emeralds, all bezel set. The gemstones alternate along the front of the necklet. The necklet is finished with an 'S' style clasp.

Necklet dimensions = 40.00cm (ave. length) x 1.55mm (ave. width) x 0.91mm (ave. depth).

Polished finish. Unstamped - acid tested as 9 carat gold.

The necklet contains:

Five bezel set oval shaped fracture filled, natural rubies, colour is "red"

Dimensions = 6.64mm(L) x 4.31mm(W) x 2.79mm(D-estimated) (smallest)

Dimensions = 7.94mm(L) x 5.64mm(W) x 3.09mm(D-estimated) (largest)

Total Weight = 4.30ct (estimated - see NOTE below)

Five bezel set oval shaped natural emeralds, colour is "green".

Dimensions = 6.77mm(L) x 4.97mm(W) x 3.27mm(D-estimated) (smallest)

Dimensions = 7.49mm(L) x 5.84mm(W) x 3.07mm(D-estimated) (largest)

Total Weight = 3.45ct (estimated - see NOTE below)

Five bezel set oval shaped synthetic sapphires, colour is "blue".

Dimensions = 6.09mm(L) x 5.34mm(W) x 3.38mm(D-estimated) (smallest)

Dimensions = 7.31mm(L) x 5.56mm(W) x 4.24mm(D-estimated) (largest)

Total Weight = 7.15ct (estimated - see NOTE below)

Total Item Weight = 7.53 grams Total Gemstone Weight = 14.90ct Total Metal Weight = 4.55 grams (estimated)

NOTE: The rubies appears to have been enhanced by means of filling with a glass type substance. This treatment is not stable and can be damaged by heat or ultrasonic frequencies. A treated ruby of this type is not commercially available in Australia. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques and based upon procuring a similar treated ruby from an overseas source. This figure includes the currency conversion, import duty, and GST. This figure does not represent the previous selling price of the ruby and will not be indicative of the resale value of the item.
