### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, hand-assembled, 18ct yellow gold, articulated, gem set necklet.

Feature radiating pendant design, consisting of multi-claw settings, each housing one round brilliant cut diamond, tapering in size, claw set. Articulated from the small tapering bail assembly.

The chain being of a diamond cut 'trace' style linkage design, having a small 'Cartier' type clasp attached, a small 'butterfly' tag, and two keepers fitted.

Polished finish - stamped '18K 750 18K D0.481ct' - acid tested as 18 carat gold.

Chain dimensions = 46.00cm (length including clasp) x 1.22mm (width).

Pendant dimensions = 25.00mm (length including bail) x 20.16 (width) x 6.27mm (depth).

The necklet contains:

One claw set round brilliant cut diamond, clarity 'Si', colour 'G'.

Dimensions = 2.44mm(Dia) x 1.49mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.05ct (estimated - see NOTE below)

Twenty Four claw set round brilliant cut diamonds, clarity 'Vs, Si & P1' (mixed), colour 'G to I' (mixed).

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.431ct (estimated - see NOTE below)

Total Item Weight = 5.40 grams - Total Gemstone Weight = 0.481ct - Total Metal Weight = 5.30 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
