Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of hand-assembled, 14ct yellow gold, gem set earrings.

Feature 'drop' style earrings, each consisting of two open back, four claw double railed settings, housing one oval cut and faceted natural emerald, claw set. The bottom setting having a fixed double 'leaf' style, claw set with two round cut and faceted colourless cubic zirconia type material, and the base of the top setting is a multi-claw 'triangular' setting design, claw set with three round cut and faceted colourless cubic zirconia type material. Post fittings with hinged back arm locking mechanism.



Polished finish - unstamped - acid tested as 14 carat gold.

Earring dimensions = 27.00mm (length) x 5.04mm (width) x 4.45mm (depth).

The earrings contain:

Four claw set mixed cut oval shape natural emeralds, colour 'medium green'.

Dimensions = 6.47mm(L) x 4.75mm(W) x 2.93mm(D-estimated)

Total Weight = 2.00ct (estimated - see NOTE below)

Ten claw set round cut and faceted colourless cubic zirconia type material.

Dimensions (average) = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Bulge)

Total Weight = 0.14ct (estimated - see NOTE below)

Total Item Weight = 3.69 grams - Total Gemstone Weight = 2.14ct - Total Metal Weight = 3.26 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
