## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.51mm width (at base) x 0.81mm depth, with open back settings, and a curved underrail.

Feature five baguette cut natural sapphires, alternating with one row of two round brilliant cut diamonds, spanning across the top of the band, all claw set. There are a total of eight round brilliant cut diamonds. The settings are secured between the shoulders of the plain and polished band.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: T.

The ring contains:

Five claw set rectangular natural sapphires, colour is "blue".

Dimensions (average) = 4.05mm(L) x 2.08mm(W) x 1.56mm(D-estimated)

Total Weight = 0.69ct (estimated - see NOTE below)

Eight claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 2.02mm(Dia) x 1.23mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 4.01 grams Total Gemstone Weight = 0.93ct Total Metal Weight = 3.82 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
