Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished raised, 9ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.30mm width (at base) x 1.13mm depth, with open back, settings underneath.

Feature, "cross over ribbon style" ring design. Comprising, three channel & claw set rows, with a cross over ribbon at top. Housin a total of one hundred & fifty baguette cut & tapered baguette cut diamonds (mixed), channel set. The outer edge of the ribbons rows, contain a total of two hundred & twenty two single cut diamonds, claw set. The extended shoulders, of the band, tapers up splits to the four ribbon rows, from both sides.



Polished finish, stamped "9K, 1.00ct" - acid tested as 9 carat gold. Finger size N.

The ring contains;

One Hundred And Fifty channel set baguette cut & tapered baguette cut diamonds (mixed), clarity is "Vs & Si"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.30mm (L) x 0.80mm (W) x 0.58mm (D-estimated)

Total Weight = 0.75ct (estimated - see NOTE below).

Two Hundred And Twenty Two claw set single cut diamonds, clarity is "Si & P1"(mixed), colour is "G to I"(mixed), medium cut quality.

Dimensions = 0.70mm (average diameter)

Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 6.95 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 6.76 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
