### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 14ct yellow gold and 14ct white gold, diamond set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 3.54mm width (at base) x 0.84mm depth, with a hollow top and shoulders, and open back settings.

Feature square white gold top plate, housing four round brilliant cut diamonds, claw set. The top plate is secured to the underrail, and in between the tapering shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped '585 14K N.A. <>' - acid tested as 14 carat gold.

Ring size: R 1/2.

The ring contains:

Four claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions = 3.47mm(Dia) x 2.12mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.63mm(Dia) x 2.21mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.64ct (estimated - see NOTE below)

Total Item Weight = 4.95 grams

Total Gemstone Weight = 0.64ct

Total Metal Weight = 4.82 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
