Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised, 18ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.63mm width (at base) x 1.24mm depth, with open back, settings, underneath.

Feature, 'end setting' to top, houses one round brilliant cut diamond, end set. To base wall both sides, contains, one round brilliant cut diamond, rub-over set. The extended shoulders, of the band, tapers up crosses to form the end setting on top. Each shoulder, containing five round brilliant cut diamonds, channel set, both sides.

Polished finish, stamped "750" - acid tested as 18 carat gold. Finger size = O.

the ring contains;

One end set round brilliant cut diamond, clarity is "P1", colour is "I", medium cut quality.
Dimensions = 5.30mm (average diameter) x 3.23mm (D-estimated) x 3.5%(Girdle Thickness)
Total Weight = 0.60ct (estimated - see NOTE below).

Twelve channel set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (smallest)
Dimensions = 2.00mm (average diameter) x 1.22mm (D-estimated) (largest)
Total Weight = 0.30ct (estimated - see NOTE below).

Total Item Weight = 5.98 grams, Total Gemstone Weight = 0.90ct, Total Metal Weight = 5.80 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
