Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold, cluster style, gem set, dress ring, of cast construction.

Plain, narrow, tapered band of 2.92mm in width (at base) x 1.03mm depth, with hollow top and shoulders, and open back settings.

Feature central sixteen claw setting, housing one oval cut and faceted natural sapphire, claw set. Surrounded by sixteen round cut diamonds, bead set. All secured between the 'double collar' style shoulder terminations of the plain and polished band.

Polished finish - stamped '375' - acid tested as 9 carat gold. Finger size is P.

The ring contains:

One claw set mixed cut oval shape natural sapphire, colour 'extremely dark blue' (heavily included to opaque).
Dimensions = 9.10mm(L) x 6.86mm(W) x 4.55mm(D-estimated)
Total Weight = 2.36ct (estimated - see NOTE below)

Sixteen bead set round brilliant cut diamonds, clarity 'Vs, Si & P1' (mixed), colour 'H to J' (mixed).
Dimensions (average) = 1.25mm(Dia) x 0.76mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.14ct (estimated - see NOTE below)

Total Item Weight = 5.06 grams - Total Gemstone Weight = 2.50ct - Total Metal Weight = 4.56 grams (estimated)



NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
