## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct white gold, gem set, pearl strand necklet, of hand-assembled construction.

Feature one strand of sixty-five cultured button shaped pearls, with white gold finals at both terminations. The strand is finished with a white gold enhancer/slide clasp, that has been embellished with a natural dyed chalcedony carving, in the shape of a "starfish". There is also one bezel setting, housing one round brilliant cut diamond, bezel set.

Necklet dimensions = 45.00cm (ave. length) x 6.40mm (ave. width).

Clasp dimensions = 21.90mm (ave. length) x 22.10mm (ave. width) x 10.90mm (ave. depth).

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

The necklet contains:

One screw set starfish natural dyed chalcedony carving depicting a starfish, colour is "blue".

Dimensions = 23.96mm(L) x 22.25mm(W) x 9.67mm(D-estimated)

Sixty Five drilled button cultured pearls, colour is "white".

Dimensions = 6.65mm(Dia) x 4.00mm (ave. depth)

One bezel set round brilliant cut diamond, clarity is "Si1", colour is "H".

Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.02ct (estimated - see NOTE below)

Total Item Weight = 24.45 grams.

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
