Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.36mm width (at base) x 1.18mm depth, with open back (cut out) settings.

Feature central three-tiered white gold channel settings, housing twenty Princess cut diamonds, graduating in size, largest to the centre, and invisibly set. The settings are secured between the extended and square shoulders, of the plain and polished yellow gold band.



Polished finish.

Stamped '750 E' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

Twenty invisibly set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to J" (mixed). Dimensions = 1.20mm(L) x 1.20mm(W) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest) Dimensions = 1.70mm(L) x 1.60mm(W) x 1.14mm(D-estimated) x 2%(Girdle Thickness) (largest) Total Weight = 0.35ct (estimated - see NOTE below)

Total Item Weight = 5.12 grams Total Gemstone Weight = 0.35ct Total Metal Weight = 5.05 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
