Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 9ct yellow gold & gemset, flexible link necklet.

Feature, double roll-over ribbon design, v-shaped pendant to centre, houses forty five round brilliant cut diamonds, & twenty four tapered baguette cut diamonds, all channel set. Triple coil ends to both sides, hollowed out open back underneath. Suspended from each side, a flat curb linked chain, with a paddle & parrot clasp closure attached to each end.

Polished finish, stamped "DLG 9K, 375" - acid tested as 9 carat gold.

Necklet dimensions = 41.00cm (total length) x 25.00mm (width) x 5.25mm (depth).

The necklet/pendant contains:

Forty Five channel set round brilliant cut diamonds, clarity is "P1, P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest)
Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated) (largest)
Total Weight = 0.68ct (estimated - see NOTE below).

Twenty Four channel set tapered baguette cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.
Average dimensions = 1.10mm (L) x 0.70mm (W) x 0.51mm (D-estimated) (smallest)
Average dimensions = 1.50mm (L) x 1.10mm (W) x 0.80mm (D-estimated) (largest)
Total Weight = 0.22ct (estimated - see NOTE below).

Total Item Weight = 8.80 grams, Total Gemstone Weight = 0.90ct, Total Metal Weight = 8.62 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
