## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's hand finished raised, 18ct white gold & diamond set, multistone ring. Plain, wide, low half round, tapered band, measures 3.40mm width (at base) x 0.86mm depth, with cut-out underrail.

Feature, "illusion" style ring design. Comprising, a raised square-shaped setting to top. Housing nine Princess cut diamonds, individual rub-over set, grouped, illusion set. The extended shoulders, of the palin band, tapers up wide to the top, from both sides.



Polished finish, stamped "18K" - acid tested as 18 carat gold.

Finger size = L.

The ring contains;

Nine illusion set Princess cut diamonds, clarity is "Si, P1, P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.30mm (L) x 2.40mm (W) x 1.70mm (D-estimated)

Total Weight = 0.75ct (estimated - see NOTE below).

Total Item Weight = 5.06 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 4.91 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
