Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished raised, 18ct white gold & gemset, multistone ring. Plain, wide, low half round, tapered band, measures 4.87mm width (at base) x 1.24mm depth, with underrail, open back settings, underneath.

Feature, "raied end setting to top, houses one oval-shaped, natural ruby, end set. The extended shoulders, taper up to the top. Each shoulder, contains fifteen round brilliant cut diamonds, bead set, both sides.

Polished finish, stamped "K18" - acid tested as 18 carat gold.

Finger size = L.

The ring contains;

One end set oval-shaped, faceted, natural ruby, colour is "medium dark -red".

Dimensions = 7.60mm (L) x 6.09mm (W) x 3.38mm (D-estimated)

Total Weight = 1.49ct (estimated - see NOTE below).

Thirty bead set round brilliant cut diamonds, clarity is "Si, P1 & P2"(mixed), colour is "H to J"(mixed), medium cut quality.

Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest)

Dimensions = 1.60mm (average diameter) x 0.98mm (D-estimated) (largest)

Total Weight = 0.45ct (estimated - see NOTE below).

Total Item Weight = 6.51 grams, Total Gemstone Weight = 1.94ct, Total Metal Weight = 6.12 grams (estimated)

NOTE: Limited gemmological testing, inset, The ruby appears natural, heavily included. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
