### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, lady's hand finished, raised 14ct yellow gold & gemset, multistone ring, of cast construction. Plain, narrow, low half round, tapered band, measures 2.14mm width (at base) x 1.10mm depth, with open back, rhodium plated underneath to highlight. Feature, "cluster setting to top" hoses nineteen round brilliant cut diamonds (mixed) sizes, grouped together, claw set. The extended shoulders, of the band tapers up wide, each shoulder having a three x step down channel settings, each side contains twenty four tapered baguette cut diamonds, channel set both sides.



Polished finish, stamped "T, JKO 14K" - acid tested as 14 carat gold. Finger size Q.

#### The ring contains;

One claw set round brilliant cut diamond, clarity is "P2", colour is "H", medium cut quality.

Dimensions = 2.70mm (average diameter) x 1.65mm (D-estimated)

Total Weight = 0.06ct (estimated - see NOTE below).

Eighteen claw set round brilliant cut diamonds, clarity is "P1, P2 & P3"(mixed), colour is "H to J"(mixed), medium cut quality.

Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest)

Dimensions = 2.40mm (average diameter) x 1.46mm (D-estimated) (largest)

Total Weight = 0.70ct (estimated - see NOTE below).

Forty Eight channel set tapered baguette cut diamonds, clarity is "Si, P1 & P2, P3"(mixed), colour is "G to H"(mixed), medium cut quality.

Average dimensions = 1.40mm (L) x 0.60mm (W) x 0.44mm (D-estimated) (smallest)

Average dimensions = 1.60mm (L) x 0.90mm (W) x 0.66mm (D-estimated) (largest)

Total Weight = 0.24ct (estimated - see NOTE below).

Total Item Weight = 8.41 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 8.21 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
