### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, lady's hand-assembled raised, 18ct white gold & diamond set, pendant.

Feature, drop style, tear-drop shaped cluster, housing eighteen round brilliant cut diamonds (mixed sized), bead set. Pendant is open backed underneath, suspended from an articulated o-ring style bail fitted & attached to top.

Polished finish, stamped "750" - acid tested as 18 carat gold.

The pendant dimensions = 27.00mm (total length inclusive) x 10.00mm (width) x 4.94mm (depth).

The pendant contains:

- Eighteen bead set round brilliant cut diamonds, clarity is "Si", colour is "G to H"(mixed), medium cut quality.
- Dimensions = 2.30mm (average diameter) x 1.40mm (D-estimated) (smallest)
- Dimensions = 2.40mm (average diameter) x 1.46mm (D-estimated) (largest)
- Total Weight = 0.92ct (estimated - see NOTE below).

Total Item Weight = 3.13 grams, Total Gemstone Weight = 0.92ct, Total Metal Weight = 2.95 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar drop style pendant, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
