## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled raised yellow (mixed metals) & gemset, drop style pendant.

Feature, "cluster style" design. Comprising, flower style cluster, houses thirteen natural, round, faceted emeralds, claw set.open back railed to back. The pendant is suspended from an articulated v-shaped bail attached to top.

Polished finish, stamped "18K (partial)" - acid tested & x-rayed.

Pendant dimensions = 27.30mm (L) x 18.21mm (W) x 7.42mm (D).

The pendant contains:

- Thirteen claw set round natural emeralds, colour is "very dark green/opaque".
- Dimensions = 4.00mm (average diameter) x 2.39mm (D-estimated) (smallest)
- Dimensions = 4.50mm (avearge diameter) x 2.39mm (D-estimated) (largest)
- Total Weight = 2.60ct (estimated - see NOTE below).

Total Item Weight = 2.61 grams, Total Gemstone Weight = 2.60ct, Total Metal Weight = 2.09 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
