Valuation for Traditional Retail Insurance Replacement

Item 1

One, pair of lady's hand-assembled raised, 14ct rose gold & gemset, drop hoop style earrings.

Feature, "single row" to front, railed & open back settings, underneath, with an articulated drop to bottom. Each earring contains, five oval-shaped, faceted, natural sapphires, claw set. Both earrings come with hinged clip & plain post attached.

Polished finish, unstamped - acid tested as 14 carat gold.

Earring dimensions = 24.92mm (L) x 5.04mm (W) x 2.99mm (D).

The earrings contain:

- Ten claw set oval-shaped, faceted, natural sapphires, colour is "medium dark blue".
- Average dimensions = 4.90mm (L) x 4.10mm (W) x 2.96mm (D-estimated)
- Total Weight = 4.80ct (estimated - see NOTE below).

Total Item Weight = 4.31 grams, Total Gemstone Weight = 4.80ct, Total Metal Weight = 3.35 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
