One, lady's hand-assembled raised, 18ct white gold & diamond set, solitaire ring.

Plain, narrow, low half round, tapered band, measures 2.74mm width (at base) x 1.57mm depth, with curved underrail.

Feature, "solitaire style" ring design. Comprising, a raised, six claw setting, houses one round brilliant cut diamond (certified & laser inscribed), claw set. The extended shoulders, of the band tapers up to the base of the central setting, from both sides.

Polished finish, stamped "18ct TIJ J" - acid tested as 18 carat gold.

Finger size = K.

One claw set round brilliant cut diamond, clarity is "Si2", colour is "E", very good cut quality.
Dimensions = 7.29 - 7.23mm (average diameter) x 4.65mm (D) x 3%(Girdle Thickness)
Total Weight = 1.55ct (known weight - see NOTE below)

Total Item Weight = 4.23 grams, Total Gemstone Weight = 1.55ct, Total Metal Weight = 3.92 grams (estimated)
