## Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of cast construction.

Plain, low half round band of 2.03mm width (at base) x 1.26mm depth, with open back settings.

Feature one row of seven shared claw settings, spanning across the top of the band. Each setting houses alternating, one round natural ruby or one round brilliant cut diamond, claw set. There were a total of four natural round rubies, and three round brilliant cut diamonds, claw set. The settings are secured between the shoulders of the plain and polished band.



Polished finish.

Stamped 'Au750 unknown makers mark' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

Four claw set round natural rubies, colour is "red".

Dimensions (average) = 2.93mm(Dia) x 1.79mm(D-estimated)

Total Weight = 0.44ct (estimated - see NOTE below)

Three claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 2.92mm(Dia) x 1.78mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 3.09 grams Total Gemstone Weight = 0.74ct Total Metal Weight = 2.94 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
