### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round band of 2.70mm width (at base) x 1.68mm depth, with open back settings, and a curved underrail.

Feature three decorative settings, spanning across the top of the band. The central four claw setting, houses one round natural tanzanite, claw set. The two side settings each house one round brilliant cut diamond, claw set. The settings are secured between the extended and square shoulders, of the plain and polished band.

Polished finish.

Stamped 'FF1364 ZA BROWNS 18ct' - acid tested as 18 carat gold.

Ring size: L 1/2.

The ring contains:

One claw set round natural tanzanite, colour is "blue".

Dimensions = 6.96mm(Dia) x 4.25mm(D-estimated)

Total Weight = 1.22ct (estimated - see NOTE below)

Two claw set round brilliant cut diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions (average) = 3.72mm(Dia) x 2.27mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.36ct (estimated - see NOTE below)

Total Item Weight = 5.35 grams Total Gemstone Weight = 1.58ct Total Metal Weight = 5.03 grams (estimated)

NOTE: The central tanzanite has significant abrasion to the crown facets. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
