Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and rhodium plated, gem set, flexible link necklet, of hand-assembled

Feature curved symmetrical centrepiece, with navette shaped panels, housing a total of thirteen round brilliant cut diamonds, graduating in size, and claw set. Suspended from the bottom of the centre piece, is one fixed bezel setting and one articulated bezel setting. Each housing one round brilliant cut diamond, graduating in size, and bezel set. The centre piece is suspended from a flat 'herringbone' style chain, that has been finished with a small bolt ring. Rhodium plating inside the diamond settings.



Necklet dimensions = 44.50cm (ave. length) x 1.61mm (ave. width) x 0.64mm (ave. depth).

Centrepiece dimensions = 45.00mm (ave. length) x 27.00mm (ave. width) x 3.50mm (ave. depth).

Polished finish. Stamped 'ITALY 750 *60TV T' - acid tested as 18 carat gold.

The necklet contains:

One bezel set round brilliant cut diamond, clarity is "Si & P1 & P2" (mixed), colour is "H".

Dimensions = 3.61mm(L) x 3.59mm(W) x 1.84mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.15ct (estimated - see NOTE below)

One bezel set round brilliant cut diamond, clarity is "P2", colour is "H".

Dimensions = 2.18mm(Dia) x 1.33mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.04ct (estimated - see NOTE below)

Thirteen claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to I" (mixed).

Dimensions = 1.17mm(Dia) x 0.71mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.42mm(Dia) x 0.87mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.16ct (estimated - see NOTE below)

Total Item Weight = 9.87 grams Total Gemstone Weight = 0.35ct Total Metal Weight = 9.80 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only.
