## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round band of 1.91mm width (at base) x 0.96mm depth, with open back settings, and a curved underrail.

Feature five shared claw settings, spanning across the top of the band, each housing one round ruby alternating with, one round brilliant cut diamond, claw set. There are a total of three round rubies, and two round brilliant cut diamonds. The settings are secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band.



Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: M 1/2.

The ring contains:

Three claw set round natural rubies, colour is "red".

Dimensions = 3.33mm(Dia) x 2.03mm(D-estimated) (smallest)

Dimensions = 3.46mm(Dia) x 2.11mm(D-estimated) (largest)

Total Weight = 0.55ct (estimated - see NOTE below)

Two claw set round brilliant cut diamonds, clarity is "Si", colour is "G".

Dimensions = 3.40mm(Dia) x 2.07mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.43mm(Dia) x 2.09mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.31ct (estimated - see NOTE below)

Total Item Weight = 2.44 grams Total Gemstone Weight = 0.86ct Total Metal Weight = 2.27 grams (estimated)

NOTE: The rubies are have significant abrasion to the crown facets. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
