## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct yellow gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 3.01mm width (at base) x 0.71 depth, with open back settings.

Feature central 'flower' style cluster, housing nine round brilliant cut diamonds, varying in size, and claw set. The cluster is secured between the 'cross over' style shoulders, of the plain and polished band. Each of the shoulders houses nine round brilliant cut diamonds, graduating in size slightly, and claw set. Rhodium plating to the diamond setting areas.



Polished finish. Stamped '750' - acid tested as 18 carat gold. Ring size: S.

The ring contains:

Nine claw set round brilliant cut diamonds, clarity is "P1", colour is "H"

Dimensions = 2.20mm(Dia) x 1.34mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.43mm(Dia) x 2.09mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Eighteen claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to I" (mixed).

Dimensions = 1.63mm(Dia) x 0.99mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 5.58 grams Total Gemstone Weight = 1.30ct Total Metal Weight = 5.32 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
