Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round band of 1.95mm width (at base) x 1.18mm depth, with a decorative curved underrail.

Feature three central claw settings, each housing one round brilliant cut diamond, graduating in size, largest to the centr, and claw set. The settings are secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band. The shoulders, and gallery is embellished with a total of eighteen round brilliant cut diamonds, varying in size, and claw set.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: K.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "I".

Dimensions = 4.14mm(L) x 4.13mm(W) x 2.75mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.29ct (estimated - see NOTE below)

Eighteen claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "I to J" (mixed).

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 2.22 grams Total Gemstone Weight = 0.56ct Total Metal Weight = 2.11 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
