Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.22mm width (at base) x 1.42mm depth, with open back settings, and a curved underrail.

Feature central three claw setting, housing one pear shaped diamond, claw set. Surrounding is two rows of round brilliant cut diamonds, claw set. The top plate is secured to the underrail, and in between the 'split' style shoulders, the extend out from the plain and polished band. The shoulders houses two rows of round brilliant cut diamonds, claw set. There are a total of thirty-seven round brilliant cut diamonds, varying in size.

Polished finish.

Stamped '375 JP02' - acid tested a 9 carat gold.

Ring size: Q.

The ring contains:

One claw set pear shaped diamond, clarity is "Si2", colour is "J".

Dimensions = 5.00mm(L) x 3.15mm(W) x 1.92mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

Thirty Seven claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "I to J" (mixed).

Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.44ct (estimated - see NOTE below)

Total Item Weight = 3.72 grams Total Gemstone Weight = 0.62ct Total Metal Weight = 3.60 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
