Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.96mm width (at base) x 0.71mm depth, with open back settings, and a curved underrail.

Feature 'flower' style cluster, with a white gold top plate, housing nine round brilliant cut diamonds, largest to the centre, claw set. The top plate is supported with an open wire base, and is secured to the underrail, and in between the extended and pointed shoulders, in 'wrap around' style, lengthening out from the plain and polished yellow gold band.

Polished finish.

Stamped 'AG 18K' - acid tested as 18 carat gold.

Ring size: L 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "H".

Dimensions = 3.40mm(Dia) x 2.07mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.15ct (estimated - see NOTE below)

Eight claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to J" (mixed).

Dimensions (average) = 2.30mm(Dia) x 1.34mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.35ct (estimated - see NOTE below)

Total Item Weight = 3.98 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 3.88 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
