## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's hand-assembled raised, 18ct white gold & diamond set, flexible link necklet.

Feature; "drop style pear-shaped pendant to centre, contains two round brilliant cut diamonds, bead set. A v-shaped bail fixed to top, suspended from a fine cable linked chain with an extender, clasped with a parrot closure, attached.

Polished finish, stamped "750, Italy" - acid tested as 18 carat gold.

Necklet dimensions = 41.50cm (length) x 0.80mm (width) x 0.74mm (depth).

The necklet contains:

One bead set round brilliant cut diamond, clarity is "Si", colour is "G", medium cut quality.

Dimensions = 1.29mm (average diameter) x 0.79mm (D-estimated)

Total Weight = 0.01ct (estimated - see NOTE below).

One bead set round brilliant cut diamond, clarity is "Si", colour is "G", medium cut quality.

Dimensions = 3.19mm (average diameter) x 2.08mm (D-estimated)

Total Weight = 0.13ct (estimated - see NOTE below).

Total Item Weight = 2.74 grams, Total Gemstone Weight = 0.14ct, Total Metal Weight = 2.71 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds would require removal from the setting. The below replacement figure is based upon crafting a similar necklet/pendant combo employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
