Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of, 14ct yellow gold, gem set, drop style stud earrings, of hand-assembled construction.

Feature tapered stud top, housing one row of three round brilliant cut diamonds, claw set. To the bottom is an articulated pear shaped drop, housing one pear shaped natural emerald, claw set. Surrounding is one row of eighteen round brilliant cut diamonds, graduating in size, and claw set. The earrings are finished with post and butterfly attachments, to the stud top.

Earring dimensions = 21.00mm (ave. length) x 11.04mm (ave. width) x 4.90mm (ave. depth).



Polished finish.

Stamped '14K ADG' - acid tested as 14 carat gold.

The earrings contains:

Two claw set pear shaped natural emeralds, colour is "green".

Dimensions = 8.65mm(L) x 6.79mm(W) x 4.42mm(D-estimated)

Total Weight = 2.54ct (estimated - see NOTE below)

Forty Two claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 1.38mm(Dia) x 0.84mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.63ct (estimated - see NOTE below)

Total Item Weight = 4.47 grams Total Gemstone Weight = 3.17ct Total Metal Weight = 3.84 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated.
