## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's hand-assembled raised, 18ct white gold & gemset, flexible link pendant/necklet.

Feature; "drop style cluster". Comprising, a semi round (button-shaped), South Sea cultured pearl to centre, end drilled & glue set. Drops to a surround, housing, twenty nine round brilliant cut diamonds, claw set. Suspended from a fine anchor linked style chain, with a bolt ring clasp closure attached to end.

Polished finish, stamped "CTF Au750,TC(chain) CTF, Au750, D0.618, B1 (Pend).

The chain dimensions = 45.00cm (total length) x 1.49mm (width) x 1.49mm (depth).

The pend/necklet contains:

One end-drilled semi-round (button-shaped), South Sea cultured silver/pink pearl, lustre is "High", blemish is "Few blemishes". Dimensions = 12.64mm (average diameter) x 11.56mm (depth).

Twenty Nine claw set round brilliant cut diamonds, clarity is "Vs & Si"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.64mm (average diameter) x 1.00mm (D-estimated) (smallest)

Dimensions = 2.18mm (average diameter) x 1.33mm (D-estimated) (largest)

Total Weight = 0.61ct (estimated - see NOTE below).

Total Item Weight = 8.39 grams, Total Gemstone Weight = 0.61ct, Total Metal Weight = 8.27 grams (estimated)
