Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct white gold, gem set pendant.

Feature decorative frame design, with pierced and textured 'leaf' design back plate, housing one carved type A Fei Cui (Jadeite Jade), in a 'leaf' shape, claw set. The frame having a bezel setting to the top and bottom, rub-over set with one single cut diamond (largest). The top curled and curved setting, claw set with fourteen single cut diamonds (smallest). Articulated from the plain and polished bail assembly.



Polished finish - stamped 'G18K' - acid tested as 18 carat gold.

Pendant dimensions = 26.00mm (length including bail) x 13.00mm (max. width).

The pendant contains:

One claw set carved natural type A Fei Cui (jadeite jade), colour 'green'.
Dimensions = 14.10mm(L) x 9.00mm(W) x 1.30mm(ave. D-estimated)

Sixteen rub-over set & claw set (mixed) single cut diamonds, clarity 'Si', colour 'H to I' (mixed).
Dimensions = 0.6mm(Dia) x 0.37mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 0.90mm(Dia) x 0.4mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.27ct (estimated - see NOTE below)

The pendant is accompanied with a Certificate of Gem Identification by Test No. G1209476-83619.

Total Item Weight = 1.90 grams

NOTE: The Fei Cui (jadeite jade) has been inspected by a Melbourne specialist for the purposes of this valuation and in the Melbourne specialist's opinion is verified. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
