Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and 9ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.06mm width (at base) x 1.13mm depth, with hollow top and shoulders, and open back settings.

Feature central white gold four claw setting, housing one oval natural sapphire, claw set. Either side of the central setting, is another four claw setting, housing one round brilliant diamond, claw set. The settings are secured between the extended and tapered shoulders of the plain and polished yellow gold band.

Polished finish.

Stamped '375 AC16' - acid tested as 9 carat gold.

Ring size: M.

The ring contains:

One claw set oval shaped natural sapphire, colour is "blue".

Dimensions = 5.82mm(L) x 4.01mm(W) x 2.60mm(D-estimated)

Total Weight = 0.51ct (estimated - see NOTE below)

Two claw set round brilliant cut diamonds, clarity is "Si", colour is "light tinted brown".

Dimensions (average) = 2.31mm(Dia) x 1.41mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.09ct (estimated - see NOTE below)

Total Item Weight = 2.28 grams Total Gemstone Weight = 0.60ct Total Metal Weight = 2.16 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
