Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, multistone, gem set ring.

Plain, narrow, tapered band of 1.61mm in width (at base) x 1.26mm depth, with hollow top and shoulders, and open back settings.

Feature central raised setting, housing twenty-five single cut diamonds (largest), claw set. Surrounded by a single row, claw set with twenty-eight single cut diamonds, also claw set. The setting having a pierced 'bridge' style design, all secured between the shoulders of the plain and polished band. Each shoulder having seven single cut diamonds, claw set. Rhodium plating inside the setting areas.



Polished finish.

Stamped '375 JP02' - acid tested as 9 carat gold.

Finger size is O.

The ring contains:

Sixty Seven bead set single cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I' (mixed).

Dimensions = 0.70mm(Dia) (smallest)

Dimensions = 0.90mm(Dia) (largest)

Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 2.72 grams

Total Gemstone Weight = 0.25ct

Total Metal Weight = 2.67 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones at very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. Th below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insuranc purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of th item.
