Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 2.56mm in width (at base) x 0.95mm depth, with curved and split underrail.

Feature multi- level 'cluster' setting design, housing a total of one hundred and five round brilliant cut diamonds, tapering in size, claw set. Secured between the extended shoulders of the plain and polished band. Each shoulder having a double row design, eight round brilliant cut dlamonds to each row, claw set. Rhodium plating to the setting areas.



Polished finish.

Stamped '9K 1.00CT' - acid tested as 9 carat gold.

Finger size is M.

The ring contains:

One Hundred And Thirty Seven claw set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'H to I' (mixed).

Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 4.66 grams Total Gemstone Weight = 1.00ct

Total Metal Weight = 4.46 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
