## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand-assembled, 18ct yellow gold and 18ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.34mm in width (at base) x 0.79mm depth, with curved underrail.

Feature central white gold four claw setting, consisting of an illusion plate setting, housing one round brilliant cut diamond, illusion set. Each shoulder having a yellow gold inverted 'V' plate, and one single cut diamond, bead set into a 'triangular' shape setting. All secured to the yellow gold plain and polished band.



Polished finish - stamped '18CT' - acid tested as 18 carat gold. Finger size is M.

The ring contains:

One illusion set round brilliant cut diamond, clarity 'P2', colour 'H'.

Dimensions = 2.71mm(Dia) x 1.65mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.07ct (estimated - see NOTE below)

Two bead set single cut diamonds, clarity 'Vs & Si' (mixed), colour 'H to I' (mixed).

Dimensions = 1.25mm (ave. diameter)

Total Weight = 0.02ct (estimated - see NOTE below)

Total Item Weight = 2.91 grams - Total Gemstone Weight = 0.09ct - Total Metal Weight = 2.89 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
