Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's 2Pce set, hand-assembled raised, 10ct white gold & diamond, multistone rings. Plain, narrow, low half round, tapered bands, combined basal width 4.27mm x 1.54mm depth, with curved underrails.

Feature, "2pce ring set". Comprising, a raised cluster ring with shoulder stones, and a contoured fitted side band, all claw set.

Polished finish, stamped "micheal hill 10K, 0.50, 0.10" - acid tested approximately 10 carat gold.

Finger size = O.

The ring set contains;

One claw set round brilliant cut diamond, clarity is "P2", colour is "G", medium cut quality.
Dimensions = 3.30mm (Diameter) x 2.01mm (D-estimated)
Total Weight = 0.14ct (estimated - see NOTE below).

Seventy claw set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "G to H"(mixed), medium cut quality.
Dimensions = 0.85mm (average diameter) x 0.52mm (D-estimated) (smallest)
Dimensions = 1.20mm (average diameter) x 0.73mm (D-estimated) (largest)
Total Weight = 0.46ct (estimated - see NOTE below).

Total Item Weight = 5.42 grams, Total Gemstone Weight = 0.60ct, Total Metal Weight = 5.30 grams (estimated)

NOTE: limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar 2pce ring set, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
