Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 18ct white gold & diamond set, multistone ring. Plain, narrow, half round, tapered band, measures 2.29mm width (at base) x 1.19mm depth, with cut-out underrail, open back settings, underneath.

Feature, "alternating row" style runs across the top of the band, housing Princess cut diamonds & baguette cut diamonds, channel set & end set (mixed). The extended shoulders, of the band tapers up wide to the top, from both sides.

Polished finish, stamped "MHJ, 750, D.23" - acid tested as 18 carat gold. Finger size = O.

The ring contains;

Two end set Princess cut diamonds, clarity is "Si & P1"(mixed), colour is "L to M"(mixed), medium cut quality.
Dimensions = 2.50mm (L) x 2.50mm (W) x 1.77mm (D-estimated)
Total Weight = 0.18ct (estimated - see NOTE below).

Six channel set baguette diamonds, clarity is "Si", colour is "J to K"(mixed), medium cut quality.
Dimensions = 2.20mm (L) x 1.36mm (W) x 0.99mm (D-estimated)
Total Weight = 0.12ct (estimated - see NOTE below).

Total Item Weight = 4.05 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 3.99 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
