### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One lady's, hand finished, raised 18ct yellow gold & gemstone set, solitaire ring.

Plain, narrow, low half round, tapered band, measures 1.94mm width (at base) x 1.51mm depth, with split underrail.

Feature, "solitaire style" ring design. Comprising, a raised four claw setting, housing one natural emerald cut emerald, claw set. The extended shoulders, of the band tapers up, splits to form the four claw setting, from both sides.

Polished finish, stamped "NJ 750" - acid tested as 18 carat gold.

Finger size = T.

The ring contains;

One claw set emerald cut natural emerald, colour is "medium dark - green".

Dimensions = 6.02mm (L) x 4.08mm (W) x 2.81mm (D-estimated)

Total Weight = 0.50ct (estimated - see NOTE below).

Total Item Weight = 3.35 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 3.25 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weights of the gemstone are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstone require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
