## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand-assembled, 18ct white gold, multistone, gem set ring.

Plain, narrow band of 1.94mm in width (at base) x 1.23mm depth, with curved underrail.

Feature central four claw central setting, housing one Princess cut diamond, claw set. Surrounded by sixteen round brilliant cut diamonds, also claw set. Four claw support base, all secured between the extended shoulders of the plain and polished band.

Polished finish - stamped '18CT' (partial) - acid tested as 18 carat gold. Finger size is S (est. offround).



The ring contains:

One claw set Princess cut diamond, clarity 'Si2', colour 'G'. Dimensions = 4.88mm(L) x 4.88mm(W) x 3.63mm(D-estimated) x 3%(Girdle Thickness) Total Weight = 0.72ct (known weight - see NOTE below)

Sixteen claw set round brilliant cut diamonds, clarity 'Si', colour 'G to H' (mixed). Dimensions (average) = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 0.15ct (estimated - see NOTE below)

Total Item Weight = 4.21 grams - Total Gemstone Weight = 0.87ct - Total Metal Weight = 4.04 grams (estimated)

NOTE: The centre diamond has been certified by Messrs. Gemological Institute of America (GIA) laboratoy Certificate number: 5223827407 Dated: June 10, 2016. The centre diamond has also been laser inscribed upon the girdle with GIA (logo) and 5223827407. Due to setting constraints, the exact dimensions of the surrounding diamonds cannot be ascertained. Therefore, weights of the surrounding diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the surrounding diamonds require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
