### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, hand-assembled, 18ct white gold, multistone, gem set ring. Plain, wide, tapered band of 3.45mm in width (at base) x 0.88mm depth, with a curved and decoratively pierced underrail.

Feature central four claw setting, housing one Princess cut diamond, claw set. Surrounded by sixteen round brilliant cut diamonds, claw set. A bezel under the setting each side, rub-over set with one round brilliant cut diamond, all secured between the extended 'ramp' style shoulders of the plain and polished band. Each shoulder having a central row of six round brilliant cut diamonds (largest tapering to smallest), channel set. The row either side having seven round brilliant cut diamonds (smallest), bead set.



Polished finish - stamped '18K DDG' - acid tested as 18 carat gold. Finger size is R 1/2.

The ring contains:

One claw set Princess cut diamond, clarity 'Vs', colour 'K'.

Dimensions = 4.71mm(L) x 4.70mm(W) x 3.25mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.65ct (estimated - see NOTE below)

Fifty Eight claw set & bead set (mixed) round brilliant cut diamonds, clarity 'Si, P1 & P2' (mixed), colour 'G to I' (mixed).

Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)  
Dimensions = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) (largest)  
Total Weight = 0.64ct (estimated - see NOTE below)

Total Item Weight = 7.26 grams - Total Gemstone Weight = 1.29ct - Total Metal Weight = 7.00 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
