Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished raised, 9ct yellow gold & diamond set, multistone ring, of cast construction. Plain, narrow, low half round, tapered band, measures 2.48mm width (at base) x 1.11mm depth, with cut-out underrail. Feature, "cluster style" ring design, with shoulder stones. Comprsing, a raised step down cluster setting to top, claw set. The extended shoulders, of the band taper up,each shoulder having three rows, Central rows channel set, outer rows claw set, both sides. Polished finish, stamped "375 JP02", acid tested as 9 carat gold. Finger size K.



The ring contains;

Five claw set round brilliant cut diamonds, clarity is "P2 & P3", colour is "H to J"(mixed), medium cut quality.

Dimensions = 2.29mm (average diameter) x 1.40mm (D-estimated) (smallest)

Dimensions = 3.47mm (average diameter) x 2.12mm (D-estimated) (largest)

Total Weight = 0.30ct (estimated - see NOTE below).

Twenty Four claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.42mm (average diameter) x 0.87mm (D-estimated) (smallest)

Dimensions = 1.79mm (average diameter) x 1.09mm (D-estimated) (largest)

Total Weight = 0.30ct (estimated - see NOTE below).

Twenty Eight claw set single cut diamonds, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 1.06mm (average diameter)

Total Weight = 0.14ct (estimated - see NOTE below).

Twenty channel set baguette diamonds, clarity is "Si", colour is "H", medium cut quality.

Average dimensions = 1.50mm (L) x 1.10mm (W) x 0.85mm (D-estimated) (smallest)

Average dimensions = 2.54mm (L) x 1.40mm (W) x 1.02mm (D-estimated) (largest)

Total Weight = 0.26ct (estimated - see NOTE below).

Total Item Weight = 3.56 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 3.36 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar material and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will no be indicative of the resale value of the item.
