## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 9ct yellow gold, gem set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.10mm width (at base) x 1.22mm depth, with open back settings, and a curved underrail.

Feature square top plate within a four claw setting, housing four Princess cut diamonds, slightly varying in size, invisibly set. The setting is secured to the underrail, and in between the extended and pointed shoulders, in a 'wrap around' style, of the plain and polished band. Each of the shoulders houses one row of three round brilliant cut diamonds, channel set.

Polished finish.

Stamped '9K NU' - acid tested as 9 carat gold.

Ring size: L 1/2.

The ring contains:

Four invisibly set Princess cut diamonds, clarity is "Si & P1" (mixed), colour is "I to J" (mixed).

Dimensions = 2.65mm(L) x 2.45mm(W) x 1.74mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.65mm(L) x 2.65mm(W) x 1.88mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.38ct (estimated - see NOTE below)

Six channel set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "I".

Dimensions (average) = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 2.92 grams Total Gemstone Weight = 0.46ct Total Metal Weight = 2.83 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of item.
