Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 18ct yellow and white gold & diamond set, three stone ring.

Plain, narrow, low half round, tapered band, measures 1.88mm width (at base) x 0.99mm depth with curved underrail, open back settings, underneath.

Feature, "trilogy style" ring design. Comprising, a white gold trilogy claw setting to the angle, houses three round brilliant cut diamonds, claw set. The extended shoulders, of the yellow gold band, tapers up, splits to each side of the trilogy setting, from both sides.



Polished finish, hallmarked "RG, 750, leopards head DIA" (purity mark London UK). 0.25 - acid tested as 18 carat gold.

Finger size = M1/2.

the ring contains;

- Three claw set round brilliant cut diamonds, clarity is "Vs & Si"(mixed), colour is "H to I"(mixed), medium cut quality.
- Dimensions = 2.49mm (average diameter) x 1.52mm (D-estimated) (smallest)
- Dimensions = 3.20mm (average diameter) x 1.95mm (D-estimated) (largest)
- Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 3.58 grams, Total Gemstone Weight = 0.25ct, Total Metal Weight = 3.53 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar material and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
