Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished raised, 18ct white gold & diamond set, multistone ring.

Plain, narrow, low half round, tapered band, measures 1.81mm width (at base) x 1.59mm depth, with curved underrail. Feature, "cluster style" ring design, with shoulder stones. Comprising, a raised four claw setting to centre, houses one cushion cut (modified brilliant), diamond (laser inscribed & certified), claw set. Drops to a surround, housing fourteen round brilliant cut diamonds, claw set. The extended shoulders, of the band tapers up, each shoulder contains eight round brilliant cut diamonds, claw set, both sides.



Polished finish, stamped "18ct" (symbol)? - acid tested as 18 carat gold.

Finger size = O.

The ring contains;

One claw set cushion cut (modified brilliant) diamond, (laser inscribed & certified), clarity is "Vs2", colour is "H", very good cut quality.

Dimensions = 4.65mm (length) x 4.30mm (width) x 2.87mm (D-estimated)
Total Weight = 0.49ct (known weight - see NOTE below).

Thirty claw set round brilliant cut diamonds, clarity is "Vs & Si"(mixed), colour is "G to I"(mixed), medium cut quality.

Dimensions = 1.28mm (average diameter) x 0.78mm (D-estimated) (smallest)
Dimensions = 1.57mm (average diameter) x 0.96mm (D-estimated) (largest)
Total Weight = 0.26ct (estimated - see NOTE below).

Total Item Weight = 3.38 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 3.23 grams (estimated)

NOTE: Limited gemmological testing, inset. The cushion cut (modified brilliant) diamond, has been certified by, and is the opinion of, Messrs. Gemological Institute of America, Certificate no.1206313436 Dated May, 20, 2019. The cushion cut (modified brilliant) diamond, has also been laser inscribed upon the girdle with GIA (logo) and 1206313436. Due to setting constraints, the exact dimensions of the other diamonds cannot be ascertained. Therefore, weight of the other diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the other diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
