Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.93mm width (at base) x 1.08mm depth, with open back settings, and a curved underrail.

Feature a white gold cluster of five shared claw settings, each housing one round brilliant cut diamond, varying in size, claw set. The settings are secured to the underrail, and in between the extended and pointed shoulders, in a 'wrap around' style, of the plain and polished yellow gold band.



Polished finish.

Stamped 'GM 18CT' - acid tested as 18 carat gold.

Ring size: L 1/2.

The ring contains:

Two claw set round brilliant cut diamonds, clarity is "Si", colour is "I to J" (mixed).

Dimensions (average) = 3.15mm(Dia) x 1.92mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.24ct (estimated - see NOTE below)

Three claw set round brilliant cut diamonds, clarity is "Si", colour is "I to J" (mixed).

Dimensions (average) = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.09ct (estimated - see NOTE below)

Total Item Weight = 4.09 grams Total Gemstone Weight = 0.33ct Total Metal Weight = 4.02 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones ar very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. Th below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of th item.
